COBIS Membership

Within three years COBIS 'Members' are expected to commit to an Inspection carried out by one of the six Department for Education (UK) approved Inspectorates under the British schools overseas (BSO) inspection framework. Further details are available at www.education.gov.uk

COBIS appreciates that a BSO inspection might not be appropriate for every school. In this case 'Members' who do not complete a BSO inspection within three years will at the discretion of the COBIS Board be expected to submit a selection of revised documents to retain COBIS Membership. At the very least these documents will include, a current child protection policy, school development plan, safer recruitment policy and articles of association for the governing body. Where CIS accreditation is held, confirmation will also be required after three years for COBIS Member status renewal.

COBIS Membership Fees 2014/15

In terms of membership fees for 2014/15, your school will qualify for a reduced rate of 25% on the full membership fee during the first academic year of membership. This will be calculated on a prorata basis for the remainder of the current academic year. Based on current rates, annual membership fees are calculated at £3.86 per pupil with a minimum charge of £495.00 per school (subject to change) and a maximum charge of £4,980.00 per school (subject to change).
